The month in brief

Activity across the tracker's 1,062 matched bills concentrated heavily in California, which accounted for 13 of the 17 movements recorded in July 2026, almost all committee reports advancing bills toward further consideration. Hawaii saw the month's most consequential development, enacting both HB 2137 and SB 3001, each addressed generally to artificial intelligence, on 14 July. Illinois also enacted a measure, SB 2909, concerning AI use in teacher evaluations. Pennsylvania's HB 2006, addressing safety requirements for companionship applications using artificial intelligence, was re-reported from committee. No bills were vetoed this period, and three bills overall passed a chamber.
