The month in brief

March 2026 saw substantial movement in data privacy legislation, with 45 bills changing stage and eight reaching enactment. Utah led in activity, signing five privacy-related measures into law, including HB 199 on health data, HB 357 on motor vehicle data privacy, and HB 450 on general data privacy amendments. Oklahoma enacted SB 546, a comprehensive consumer data privacy bill establishing consumer rights, appeal processes, and penalties. Connecticut reported ten bills out of committee, more than any other state, covering subjects from consumer privacy to data security for financial institutions.
